## Terms of Use

These terms of use ("Terms of Use") apply to the Global Alliance for Clean Cookstoves (the "Alliance") website (the "Site") operated, managed and controlled by the United Nations Foundation ("we", "us", or "UNF"). By accessing or using the Site, you agree to be bound by these Terms of Use and our Privacy Policy [www.cleancookstoves.org/termsfuse](http://www.cleancookstoves.org/termsfuse). **These Terms of Use affect your legal rights and obligations. If you do not agree to be bound by all of these Terms of Use, do not access or use the Site.**

WE RESERVE THE RIGHT TO CHANGE THESE TERMS BY POSTING REVISED TERMS ("UPDATED TERMS") AT ANY TIME. THE UPDATED TERMS WILL BE EFFECTIVE AS OF THE TIME OF POSTING. YOUR CONTINUED USE OF THE SITE FOLLOWING ANY CHANGE WILL BE DEEMED ACCEPTANCE OF ANY CHANGE IN THE TERMS AND CONDITIONS. ALTHOUGH WE MAY ATTEMPT TO NOTIFY YOU VIA YOUR E-MAIL ADDRESS WHEN MAJOR CHANGES ARE MADE, YOU SHOULD VISIT THIS PAGE PERIODICALLY TO REVIEW THE TERMS.

## Permitted Use:

1. You may download items of content on the Site for personal use, except in any instance where we have expressly restricted the access to or copying of such materials. You may make and lend an electronic or print copy of an individual item of content on the Site to another person, provided that such copies are not routinely or systemically lent (whether on one occasion or over a period of time); that such copies do not reproduce any proprietary legends included on the materials; and that the reproduction and lending is done without any purpose of direct or indirect commercial advantage. ## Restrictions on Use:

The place of arbitration shall be New York, USA and will be governed by and interpreted in accordance with the laws of New York, without regard to conflicts of laws rules or principles. The language of the arbitral proceedings shall be English (or as determined between parties). Judgment upon any award(s) rendered by the arbitrators may be entered in any court having jurisdiction thereof. The arbitrator is authorized to include in the award an allocation to any party of such costs and expenses, including attorneys' fees, as the arbitrator shall deem reasonable.

If any provision of these Terms of Use is held to be unlawful, void, or for any reason unenforceable during arbitration or by a court of competent jurisdiction, then that provision will be deemed severable from these Terms of Use and will not affect the validity and enforceability of any remaining provisions. UNF's failure to insist upon or enforce strict performance of any provision of these Terms will not be construed as a waiver of any provision or right. No waiver of any of these Terms will be deemed a further or continuing waiver of such term or condition or any other term or condition. UNF reserves the right to change this dispute resolution provision, but any such changes will not apply to disputes arising before the effective date of the amendment.

### **Time Limitation on Claims**

You agree that any claim you may have arising out of or related to your relationship with UNF and/or the Alliance must be filed within one year after such claim arose; otherwise, your claim is permanently barred.

### **Entire Agreement**

If you are using the Site on behalf of a legal entity, you represent that you are authorized to enter into an agreement on behalf of that legal entity. These Terms of Use constitute the entire agreement between you and UNF and governs your use of the Site, superseding any prior agreements between you and UNF. ### **Territorial Restrictions**
